The program is comprised of:

- An Executive Education curriculum developed and instructed by Rutgers University to sharpen the knowledge base and business skills of certified MBEs;
- The expertise of our Corporate Members shared through one-on-one Executive Coaching forums designed to facilitate the practical application of the professional business skills necessary to go to the next level;
- Mastermind sessions consisting of speakers and/or seminars that will build on the key concepts taught throughout the program; and
- Dynamic peer to peer sessions to discuss growth strategies and establish ongoing relationships that could lead to future Tier I/Tier II opportunities.

By the end of this program, participants will be able to:

- Apply sharper business management and leadership skills;
- Build the capacity of their business through committed and loyal employees;
- Confidently respond to RFPs and pursue Tier1/Tier 2 Supplier Diversity opportunities;
- Maintain a healthy flow of Working Capital in their business;
- Increase the influence of their Brand in the marketplace in a way that clearly and succinctly communicates the competitive advantages of doing business with their firm;
- Develop and launch new products and/or services that strategically align to the business-critical goals of Corporate Member firms; and
- Streamline work processes through innovation and transformational leadership that optimizes performance and eliminates inefficiencies.

Along with instruction from the Rutgers University Center for Urban Entrepreneurship &



Economic Development, MBE participants will have the opportunity to work one-on-one with Council corporate members.

The monthly time commitment for participation in this program is approximately 8 hours. This includes classroom, coaching, mentoring, meetings, seminars and assignments.
