Hello Alice, a non-profit whose mission is to support small business owners, recently became the subject of a lawsuit by America First Legal (AFL), led by Stephen Miller, and Jonathan Mitchell. The lawsuit claims that Hello Alice's work with Progressive Insurance — which resulted in offering \$25,000 grants to ten Black-owned small businesses — violates civil rights.

Hello Alice states that their "values are not 'gentle-sounding euphemisms.' These are the pillars upon which [they] built Hello Alice and guide [their] mission to drive capital, connections, and opportunities into the hands of small businesses of all types and backgrounds.

What does this mean for you as an MBE?

Stay aware. Stay solvent. Stay mindful that your work matters.

Multiple Award Schedules were created to help simplify the contracting process by allowing the government to purchase straight from MAS Contract holders with agreed-upon prices and terms and conditions,

making for a quick and streamlined purchasing process. While GSA Multiple Award Schedules can lead to governmental sales, there are many things to consider before jumping in such as the following:

- Are you eligible? Some eligibility requirements include having been in business for at least two years, having a relevant past performance, and being financially stable.
- Can you dedicate the necessary time to fully understand and assemble a competitive application?

At the Denver MBDA Business Center, we can help you understand the benefits of GSA Multiple Award Schedules, as well as the stringent eligibility requirements. Getting a GSA MAS Contract is by no means simple, so we can also help you understand the application process and give you tips on best practices for creating your proposal.

This month our discussion is about BIL, or the Bipartisan Infrastructure Law. The Bipartisan Infrastructure Law refers to a major piece of legislation that was passed in the United States in 2021. The bill aimed to address various infrastructure needs across the country, including investments in transportation, broadband, water systems, power & energy, and more.

BIL is about investing in America and there are historic levels of private sector investments including:

- · Bringing back manufacturing jobs
- · Rebuilding roads and bridges
- · What is the impact of these investments across the U.S.

The guidebook to BIL is a roadmap to the funding available under the law, as well as an explanatory document that shows, in as much detail as currently available, program-by-program.
